GATING ORDER (NO. 1) 2012

HIGHWAYS ACT 1980 SECTION 129A

The Council of the Borough of Luton in exercise of its power under Section 129A of the Highways Act 1980 ("the Act") and all other enabling powers and being satisfied that the conditions set out in Section 129A of the Act have been met hereby makes the following Order.

1. This Order shall come into operation on 31st July, 2012 and may be cited as The Borough of Luton (Leyhill Drive to Homestead Way Park Footpath) Gating Order (No. 1) 2012.
2. Except as provided in Article 3 of this Order no person shall use the public right of way over the length of the highway described in Part 1 of the Schedule to this Order and shown on the plan annexed to this Order at any time.
3. The restriction in Article 2 shall not apply to any person who lives in premises adjoining the length of highway and anyone authorised by them or to any business premises adjoining the lengths of highway or to any Police, Ambulance or Fire Service personnel acting in pursuance of statutory powers or duties, persons acting in their capacity as officers of the Council or anyone authorised by the Council or to any statutory undertaker, gas, electricity, water or communication provider requiring access to their apparatus situated in the highway.
4. The alternative route for pedestrians and vehicles affected by this Order is by using the public right of way over the highway described in Part 2 of the Schedule to this Order and shown on the plan annexed to this Order.
5. The Council is satisfied that the conditions set out in Section 129A(3) of the Act have been met in relation to this Order.
6. The installation, operation and maintenance of lockable gates to enforce the restriction of public rights of way is hereby authorised.
7. Maintenance and operation of the gates will be the responsibility of Luton Borough Council. If you need to contact the Council regarding the gates please telephone Vicky Hawkes, Community Safety Team on (01582) 394177.
8. This Order will be available for inspection at the Central Depot, Kingsway, Luton, LU4 8AN for a period of one year from 17th July, 2012 and will be published on the Council's website.

9. This Order will be registered in the Register of Gating Orders at the offices of the Community Safety Team, Central Depot, Kingsway, Luton, LU4 8AN and a copy of the Order will be available to members of the public on payment of a reasonable charge.



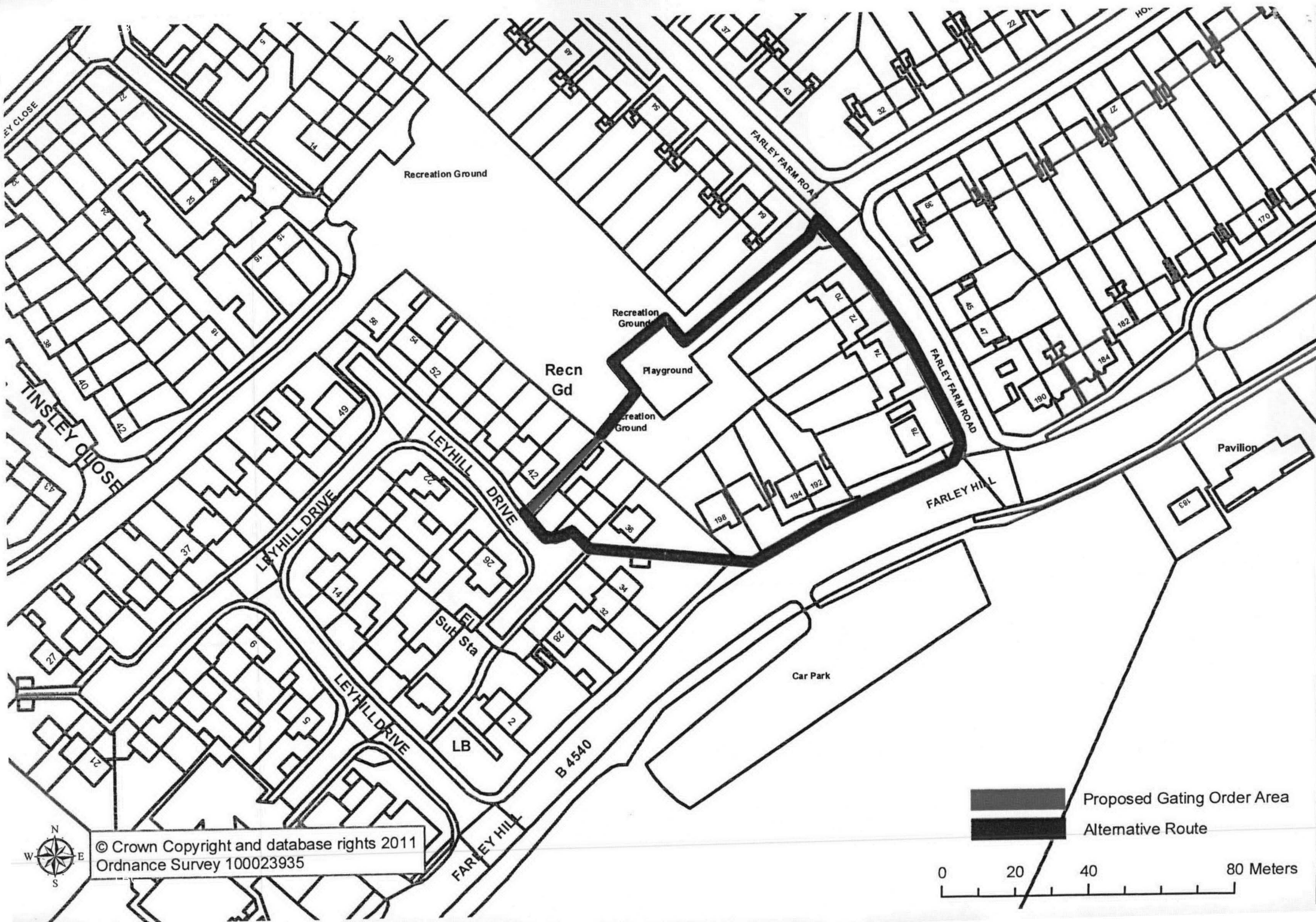
