*Registering for free meals could raise an extra £1,345 for your child's school, to fund valuable support like extra tuition, additional teaching staff or after school activities.

This additional money is available from central government for every child whose parent is receiving one of the welfare benefits listed in this form. It is therefore important to sign up for free school meals, even if your child is in reception, year 1 or year 2, so that your child's school receives as much funding as possible.

From 1 April 2018, transitional protections will be awarded for those pupils who might otherwise lose free school meals following an update to their eligibility criteria. The transitional protection will be awarded throughout the roll out of Universal Credit. Once Universal Credit has been fully rolled out any existing pupil who no longer meets the eligibility criteria will continue to receive free school meals until the end of their current phase of education ie primary or secondary.
