**THE BOROUGH OF LUTON (RED ROUTE) (NO. 2) EXPERIMENTAL TRAFFIC ORDER
2018 VARIATION ORDER (No.2) 2019**

Made on 19 August 2019

Wellington Street Coming into force 02 September 2019

The Council of the Borough of Luton in exercise of the powers conferred by sections 9, 10 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹ ("the 1984 Act") as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order—

Citation and commencement

1. This Order may be cited as The Borough of Luton (Red Route) (No.2) Experimental Traffic Order 2018 Variation Order (No.2) 2019 and shall come into force on 02 September 2019

Variations

2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Borough of Luton (Red Route) (No. 2) Experimental Traffic Order 2018² shall have effect as though:-
 - (a) for the items in Schedule 1 to that Order numbered 30 and 31 there were substituted the items similarly numbered and set out in columns (1), (2) and (3) of Schedule 1 to this Order;
 - (b) there were added to Schedule 1 to that Order the item numbered 33 (and set out in columns (1), (2) and (3) below:

33.	Stuart Street, Luton Northern side (even numbered side) from a point opposite the boundary of Nos 28/30 Stuart St to a point 12 m east of the eastern kerb line of Wellington Street.	At any time

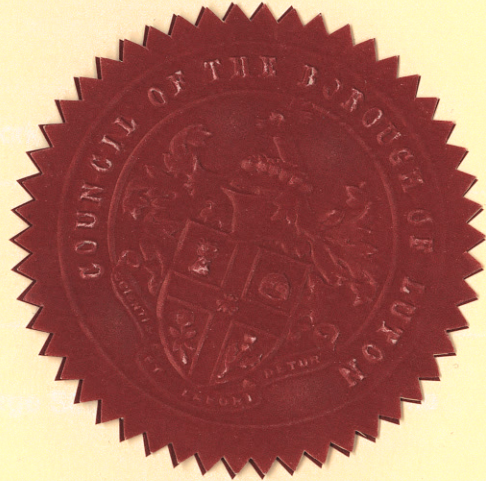
