If granted, the licence will enable the following to take place:

- *THIS APPLICATION IS TO UPDATE THE CHANGES TO THE INTERNAL LAYOUT OF THE PREMISES, INCORPORATING THE PREVIOUS STORE AREA TO HAVE HOUSEHOLD PRODUCTS. ALCOHOL AREA REMAINS THE SAME AT THE REAR.*
- *ALSO AS THE DEMAND FOR 24 HOUR CONVENIENCE STORE IN THE AREA, APPLICANT WOULD LIKE EXPAND THE OPENING AND LICENSING HOURS TO 24 HOURS.*
- *THE CONDITIONS ON THE CURRENT LICENCE HAS BEEN UPDATED/ REMOVED TO INCLUDE THE CURRENT CONDITIONS WITH ADDITIONAL CONDITIONS TO SUPPORT THE 24 HOUR OPERATIONS.
