Introduction

National planning practice guidance (NPPG) explains the purpose of this register:

‘Brownfield land registers will provide up-to-date and consistent information on sites that local authorities consider to be appropriate for residential development having regard to the criteria set out in regulation 4 of the Town and Country Planning (Brownfield Land Register) Regulations 2017. Local planning authorities will be able to trigger a grant of permission in principle for residential development for sites in their registers where they follow the required procedures. Registers will be in two parts, Part 1 will comprise all brownfield sites appropriate for residential development and Part 2 those sites granted permission in principle. Registers should be published locally as open data and will provide transparent information about suitable and available sites.’

The [NPPG](#)¹ and [2017 regulations](#)² provide further information on the need for and use of the register.

Method

The Government has provided a [data template and specification](#)³ that was used in the production of this register.

The following text explains the basis of site selections and how information contained in certain columns has been sourced. It should be noted that Luton Council is not proposing any sites for the second part of the register, which is discussed in more detail later in the report.

Site Selection

The 2019 Strategic Housing Land Availability Assessment (SHLAA) was used to identify relevant land. This is the source recommended by national guidance on the production of brownfield land registers.

All of the sites from its appendix 2 were filtered to select those that met all of the following criteria:

1. comprise previously developed (brownfield) land
2. assessed as being suitable for residential development and
3. available now or have a reasonable prospect of becoming available in the next 15 years
4. achievable now or have a reasonable prospect of becoming achievable in the next 15 years

Ownership Status

This has been set to ‘unknown ownership’ for most sites. The council does not hold full land ownership details for all land across the town and it is disproportionately expensive to acquire this data for all of the sites in this register. The register contains a link to the planning history of each site, which allows any interested party to view planning application details that provide indicative information on ownership.

Deliverable

The deliverability of sites is sourced from the SHLAA (appendix 2).

Planning Status, Permission Type, Permission Date and Development Description (Housing and Non-housing)

The history of all sites was reviewed in December 2019. This represents an updated position over the SHLAA, which is based on planning activity up to 31 March 2019.

The information here relates to the most recent planning application submitted for residential development.

Any additional, extant permission is identified in the notes column.

Minimum and Maximum Dwellings

The minimum number of dwellings is sourced from the 2019 SHLAA. The maximum number of dwellings is calculated at 10% greater than the minimum.

These numbers should not be taken as absolute constraints. Luton Council will consider every planning application on its own merits and may approve applications with levels of development above or below these numbers if the proposal is acceptable in planning terms.

Only sites without an extant permission or impending decision have this information.

Part 2 of the Register

Luton Council has decided not to enter any sites into the second part of the register. There will be no potential grants of permission in principle at this time.

The Luton Local Plan 2011-2031 was recently adopted 07 November 2017, allocating sufficient sites to support the delivery of new homes. The plan was formally inspected through a rigorous public examination and it was found that there is a sufficient supply of housing sites (having a reasonable certainty of coming forward in the plan period) to meet housing targets.

CSV Format

The information presented in this report is a version of the main data file that has been modified slightly to be more reader-friendly.

The full dataset is available as a comma separated values (CSV) format, in the manner prescribed by Government. This CSV file is published on-line alongside this report.
